HOLLYWOOD OS® promotes truth, trust, privacy and security as core attributes of our service to subscribers and non-subscribers. HOLLYWOOD OS® has created this Privacy Policy demonstrate our firm commitment to your privacy. This Privacy Policy is applicable to the website owned and operated by Hollywood OS® and reserves the right to change this Policy and any Company Policy, Staff, Ownership, Management Change, Guidelines, Rules, Regulations, at any time. Your continued use of this the Hollywood Operating System® Website will signify your acceptance of all updates and changes. It is your responsibility to review the Terms of Use, Legal Notices and Privacy Policy in a timely fashion.

HOLLYWOOD OS® views your privacy as one of its most important values. Accordingly, HOLLYWOOD OS® wants you to know how it protects your information and the choices you have about how it is used. The following Privacy Policy points summarize and clarify HOLLYWOOD OS® commitment to you, including: how it safeguards your privacy, how it treats personal information, and the choices you have concerning its use of your information. HOLLYWOOD OS® understands that for you to take full advantage of the benefits of this interactive medium, it must act reasonably to ensure your privacy.

I. COLLECTION AND USE OF INFORMATION

HOLLYWOOD OS® is the sole owner of the information collected on this site. We will not sell, share, or rent this information to others in ways different from what is disclosed in this statement. HOLLYWOOD OS® collects information from our users at several different points on our website. Passwords and user identification codes for all users accessibility, content and authorization cannot be transferred or loaned. Said misuse can result in the permanent revoke, access loss, non-refundable. No account holder shall distribute, promote or solicit other members without the expressed written consent and authorization of HOLLYWOOD OS®. Such abuse will not be tolerated. Violations could result in legal action.

A. Subscription Information

In order to become a Subscriber of HOLLYWOOD OS®, a user must first complete the registration form. During registration a user is required to give their contact information (such as email address). This information is used to contact the user about the services on our site for which they have expressed interest. It is optional for the registered user to provide any demographic information and unique identifiers such as social security numbers, but encouraged so we can provide a more personalized experience on our site. As described below, paying subscribers will only be asked for such information as they need to complete their portfolio and payment information, but such information may be required for Subscription.

B. Order

We request information from the user on our registration form. Here a user must provide contact information (like name and shipping address) and financial information (like credit card number, expiration date). This information is used for billing purposes and to fill customer's orders. If we have trouble processing an order, this contact information is used to get in touch with the user. In addition, our registration form requests, and in some cases requires, additional user information, including resume information, demographic information, and other items. Where such information is requested, users are not obligated to provide it, but are encouraged to do so in order to allow a more personalized experience on our site. Where such information is required, generally because it is necessary for the proper functioning of HOLLYWOOD OS® product offering, you will not be able to subscribe to HOLLYWOOD OS® without providing the information.

C. HOLLYWOOD OS® does not read your private online communications.

HOLLYWOOD OS® honors the confidentiality of its Subscribers private communications in private chat rooms and E-mail messages. However, we reserve the right to revoke such private communication at any time if we feel our Terms of Use have been violated. HOLLYWOOD OS® does not read or disclose private communications except to comply with valid legal process such as a customer complaints, search warrant, subpoena or court order, to protect HOLLYWOOD OS® rights and property, or during emergencies when it believes physical safety is at risk. Of course, what you write or post in public chat rooms and message boards is available not only to HOLLYWOOD OS®, but to all Subscribers and/or other users of the Website. The HOLLYWOOD OS® forum is exclusive to Subscribers, casting directors and HOLLYWOOD OS®. Some forums are not private message boards. However, your name and photo will appear if you post on other various boards.

HOLLYWOOD OS® does not give out your telephone number, email addresses, usernames, or other contact information unless you authorize it to do so. HOLLYWOOD OS® gives you the opportunity to correct your personal contact information at any time and provides you information on how this can be done. Email removal information is also contained within every casting alert.

When you subscribe as a paying Subscriber of HOLLYWOOD OS®, you are asked for your name, address and telephone number and are given a user name to use on HOLLYWOOD OS®. Here is how HOLLYWOOD OS® protects that information:

- 1) HOLLYWOOD OS® will not give out your contact information except as you have authorized us to do so. HOLLYWOOD OS® gives you the opportunity to designate what contact information may be provided to other Subscribers and/or users of the Website and to Industry Professionals, who may then use such information to contact you. Also, in order for HOLLYWOOD OS®'s product offering to function properly certain Subscriber contact and portfolio information is always available to Industry Professionals, and Industry Professionals are entitled to share such information (including, without limitation, by forwarding portfolio URLs containing contact and portfolio information, which forwarded portfolio URLs will be accessible to persons other than Industry Professionals) for only a limited period of time, for project specific professional purposes. Although HOLLYWOOD OS® requests Industry Professionals to submit certain credentials to HOLLYWOOD OS® and to make certain representations to HOLLYWOOD OS® cannot ensure that such credentials and representations are truthful and correct. HOLLYWOOD OS® subjects Industry Professionals to a limited review process before they are allowed to access the Website, however, HOLLYWOOD OS® cannot represent or warrant that any Industry Professional is legitimate or will use your personal information appropriately and/or in compliance with such Industry Professional's agreements with HOLLYWOOD OS®.
- 2) When you participate in public areas of the Website the information you post is available for all users of the Website to see. Accordingly, you should not post private or sensitive information to the Website.
- 3) When you provide information in connection with open casting notices, such information is available to the persons posting such open casting notices (who may or may not be Industry Professionals) and, unless otherwise specified, may be used by them as they see fit.
- 4) HOLLYWOOD OS® may provide aggregated demographic information to third parties, but it will not disclose your individual personal information to any third parties without your prior consent. HOLLYWOOD OS® also collects and uses other anonymous statistical information for internal purposes.
- 5) HOLLYWOOD OS® partners with other companies to provide specific services and offers to users. When a user signs up for these services, such as magazine subscriptions or other promotional offers, HOLLYWOOD OS® will share names and other information (including, where applicable, credit card information) that is necessary for the third party to provide these services. These parties are not allowed to use personally identifiable information except for the purpose of providing these services or as otherwise specified in connection with the applicable offers.
- 6) There is an important exception to the foregoing policies. HOLLYWOOD OS® will release specific information about you or your account activity to comply with a search warrant, subpoena or court order, or in special cases such as when a physical threat has been made to you or others. We use an outside shipping company to ship orders, and a credit card processing company to bill users for goods and services. These companies do not retain, share, store or use personally identifiable information for any secondary purposes. F. NEWSLETTER

If a user wishes to subscribe to any newsletters we may offer, we ask for contact information such as name and email address.

G. SURVEYS & CONTESTS

From time-to-time our site requests information from users via surveys or contests. Participation in these surveys or contests is completely voluntary and the user therefore has a choice whether or not to disclose this information. Information requested may include contact information (such as name and shipping address), and demographic information (such as zip code, age level). Contact information will be used to notify the winners and award prizes. Survey information will be used for purposes of monitoring or improving the use and satisfaction of this site.

H. REFERRALS

If a user elects to inform a friend about our site, all we ask for the friend's name and email address. HOLLYWOOD OS® will send your friend a onetime email inviting them to visit the site. The friend may contact HOLLYWOOD OS® anytime to request the removal of their information from our database.

I. SPECIAL OFFERS

We send all new Subscribers a welcoming email or other correspondence to verify password and username. Established Subscribers will occasionally receive information on products, services, special deals, and a newsletter. You may contact HOLLYWOOD OS® anytime and have your name removed from this list if you do not want to receive this special offer information.

J. SITE AND SERVICE UPDATES

We also send the user site and service announcement updates. Subscribers are not able to un-subscribe from service announcements, which contain important information about the service. We communicate with the user to provide requested services and in regards to issues relating to their account via email, online posts or phone. It is the responsibility of the Subscribers/Registered Non-Subscribers to regularly review the Terms of Use, Privacy Policy and Legal Notices for any changes and updates.

K. SECURITY

HOLLYWOOD OS® strives to use state-of-the-art technology to keep your personal information as secure as reasonably possible. When our information/registration/order form asks users to enter sensitive information (such as credit card number and/or social security number), that information is encrypted and is protected with what is among the best encryption software in the industry, but we cannot guarantee the security of one's private information in this age of technology.
